**Subject:** Update on Global Household Goods Contract (GHC) Phase-in and 2024 Peak Season Operations

1. The Defense Personal Property Management Office (DPMO) at U.S. Transportation Command (USTRANSCOM) offers the following information about the GHC domestic phase-in beginning in spring 2024.

2. **GHC Phase-In Timeline:** DOD will begin executing shipments under GHC at selected locations in April 2024, and continue at those locations throughout the 2024 peak moving season (15 May through 31 August). During the 2024 peak moving season, DOD will operate the current Tender of Service (TOS) program worldwide and the GHC program at selected locations with limited volumes.

3. **Initial GHC Phase-In Locations:** The locations identified by the military departments to begin phase in no earlier than 1 April are as follows:

4. **GHC Phase-In Peak Season Volume:** The DOD will maintain control of the pace and volume of GHC phase-in. The goal for initial phase-in across the selected locations will be less than 1% of the total national monthly average number of shipments (based on three years of historic domestic data) through July of 2024 and less than 2% in August 2024.

5. **TOS Program Shipments:** Shipments not selected for the GHC phase-in will move under the current TOS program. This will be the majority of servicemember moves in peak season 2024.

6. **GHC Phase-In Post-Peak Season:** At the conclusion of the 2024 peak season, DOD will continue the GHC phase-in by increasing volume at the initial phase-in locations as well as expanding to other locations across the U.S. Projected volume is 4% for September; 10% for October and November, and 20% for December. Plans call for continued increase in the volume of domestic shipments into 2025. International GHC phase-in will begin no earlier than September 2025.

7. **Disclaimer:** GHC Phase-In locations and volume are subject to change or adjustment. DPMO will publish updated schedules as needed.

8. DPMO will continue to update DOD personnel and our valued industry partners as we progress through full GHC implementation.
